## 1. LMS Nurse-Attendance Design Group Meeting

  - Discussed the need for flexibility in the nurse's office layout.
  - A double lock medication cart has been factored into the proposed design.
    Location for an ice maker is still to be determined.
  - General treatment setup includes six chairs, drawers with counters, and upper cabinets for quick treatment.
  - Mentioned the existing "Grab n' Go" cart for supplies is a useful feature that must be accounted for into the new layout.
  - Discussed the need for additional nurse's movable desks and cots for patient care.
  - Emphasized the importance of proper ventilation and the need for more private spaces, including toilets.
  - Suggested the sequence for student checkouts and attendance procedures.

  - Teachers were asked to provide details on equipment needed and preferred sizes for shared lab tables.
  - Emphasized the need for a larger room with ample power outlets and cord management for devices.
